10.	<p>South Cambs District Council:</p> <p>10.1 District Cllr Van de Weyer gave further information about what might be expected under <u>devolution</u>.</p> <p>10.2 <u>Budget</u> was to be set this month. He believed the increase would be either 3% or £5m.</p> <p>10.3 <u>Cycle route</u>: the A10 stretch between Foxton to Harston is now complete. The work to extend to Shepreth is starting soon. Consultation on Harston cycleway should be later this year.</p> <p>10.4 <u>Changes to the Planning Scheme of Delegation</u> – results of consultation has been published and circulated to councillors. Any further comments are required by 19th February. The next planning forum is 22nd March and Cllrs Fletcher and Potter to attend.</p> <p>10.5 <u>Tree consultation on works to 7 Orwell Road</u>.
